Dear GDS members,

I hope you are all doing well and flourishing. We are looking forward very much to seeing those of you who can make it to the Annual Convention in Toronto next year!

It has been an enormous pleasure to put together the program for the section over the summer and to see the amazing work being done by colleagues everywhere. We had about twice as many proposals for papers, roundtables and panels as we could accommodate, meaning that some difficult choices had to be made along the way. Where we could, we leaned towards supporting a diversity of colleagues in different geographical locations and career stages.

Regarding our section program for the annual convention, we have 97 sponsored and cosponsored panels for the section, working from our initial allocation of 52 through cosponsoring. This makes us the 6th biggest section in terms of presence on the program (excluding the conference theme). We are still in the process of finalizing the program – thanks to the many of you who have kindly volunteered to act as chairs and discussants; this is the indispensable labour that makes the convention work as a space for engaging scholarship seriously and in a welcoming environment.

There are three particular panels I would like to flag to you at this stage:

- Our <u>Eminent Scholar</u> panel (Friday, 15.45-17.30) which this year will honour Professor Nancy Fraser of the New School
- Our <u>Annual GDS Roundtable</u> (Wednesday, 13.45-15.30), which this year is titled 'Planetary Futures, Developmental Pasts, and the Ongoing Colonial Climate'
- A new <u>collaboration with the Global South Caucus</u> (Saturday, 8.15-10.00), which is this year a roundtable titled 'Does the Global South need Decolonial/Postcolonial Theory? A Debate'

Beyond this, we would like to enlist your help in growing the registered membership of the Global Development Section. If you have colleagues or graduate students whose interests fit with our themes, please do encourage them to sign up to the section. Our membership numbers are important not only for the section's budget but also the allocation of space on the program.

Teresia Teaiwa Student Paper Award

-- This proposal will be discussed at the 2019 GDS business meeting:

Teresia Teaiwa (1968-2017) was a feminist committed to decolonizing scholarly knowledge. Teresia's many and diverse contributions were framed by a feminist commitment to examining the relationships between gender, militarism and the militarization of Oceania as well as by an intention to retrieve a cosmopolitan vision of Oceania that acknowledged the region as a nucleus of international politics and culture. Moreover, Teresia held a deep commitment to Pacific-oriented teaching and learning, which was especially notable in her support and mentoring of students and scholars from Oceania. Teresia's work exemplifies the way in which the intellectual projects of Global Development (GDS) and Feminist Theory and Gender Studies (FTGS) are co-implicated. As a way of encouraging a closer working relationship between GDS and FTGS, and in order to honor Teresia's commitment to Pacific scholarship, we would like to propose a paper award in her name.

The Teresia Teaiwa Student Paper Award would be jointly and equally provided for by GDS and FTGS. The awardee would receive \$800, which they will be encouraged- but not required- to use for travel costs to the ISA annual meeting. Selection criteria for the award would include: current students studying in Oceania at PhD level or equivalent, worthiness (and acceptance) of paper to be presented. Historical representation of the student's institution at ISA might also be considered. A board of two members of GDS and two members of FTGS would evaluate the application. The board would change every three years.

GDS BOOK AWARD WINNERS

Book Award Committee

The GDS Book Award Committee is pleased to announce the award winner for 2019:

Decolonising Intervention: International Statebuilding in Mozambique by Meera Sabaratnam, published by Rowan & Littlefield International. Sabaratnam's book explores the persistence of colonial attitudes, assumptions and practices in international development interventions, and makes a significant contribution to global development literature and practice. Her research uses a case study of statebuilding in Mozambique, which covers political and economic aspects of statebuilding interventions, to illustrate how, even with well-meaning development interventions that seek to be inclusive and participatory, colonial and Western assumptions prevail and undermine the intervention. She demonstrates how most intervention and intervention analysis focuses on the interveners and not the recipients, or 'targets' of the intervention. Using a framework that emphasizes the historical, political and material experiences and realities of the 'target' societies of intervention, she offers a way forward for global development conceptualization and practice.

Market published by Cambridge University Press. Paul's analysis of Asian domestic worker migration patterns provides the global development literature with additional insight into how migrants build social and economic capital to achieve their goals. The research reveals that migrants engage in complicated maneuvering migration patterns rather than simply migrate from country of origin to country of destination. Utilizing interview data and assessment of migrant stock numbers, Paul provides a glimpse into the motivations and actions of Indonesian and Filipino migrant domestic workers, uncovering how they utilize social networks to their own advantage. Paul's stories reveal that migrants have individual agency and autonomy but also that they encounter structural limitations in the international labor market and are highly vulnerable in national markets and government legal structures. The research challenges us to consider the complexity of the migrant domestic worker experience, especially considering the fluctuating nature of the globalized labor market.

Honorable mention goes to Naohiko Omata for *The Myth of Self-Reliance: Economic Lives Inside a Liberian Refugee Camp*, published by Berghahn Books. Omata's study of a Liberian refugee camp in Ghana contributes significantly to the refugee studies literature. With considerable time spend in the field, living in the camp with refugees, the researcher came to an intimate understanding of livelihoods and relationships in a camp that had been touted by the UNHCR as a success. This success, of 'economic self-reliance' was found to be based on remittances from Liberians living in the U.S., thus upending the assumption of 'self-reliance' within the camp. This research is significant for policymakers and scholars to consider how livelihoods occur in refugee camps, where dependencies appear, and the critical role of societal structures and relationships.

To be eligible for the Edward Said Award, you will be:

- Accepted to the ISA Toronto Program to present the paper you wish to submit to be considered for the Award.
- Attending the ISA Toronto Convention (barring any exceptional, unforeseen circumstances).

Prize

The winner will receive the Award during the GDS Section Reception on 29th of March at the Toronto Convention; in addition to the Award, the winner will also receive a small cash prize of \$200.00.

Selection Process

The submissions will be evaluated by the Awards Committee, and the winner will be notified one week before the commencement of the ISA Convention in Toronto.

Committee members will be looking for papers that make a distinctive contribution either conceptually, empirically, or both to the broad field of Global Development Studies.

Apply For This Award

Eligible candidates should make sure that papers intended for submission to the GDS Awards Committee are fully referenced, no less than 7000 and no more than 9000 words in length, and satisfy the basic editorial requirements for a journal article submission.

The paper should not have been accepted or even submitted for consideration for publication until award results have been informed.

Special Edition: "70 years of United Nations peace operations: assessments and perspectives" (Conjuntura Internacional)

Since the deployment of the first peace operation under the aegis of the United Nations in 1948, the activities authorized for the management and resolution of conflicts of such multilateral instrument have been progressively widened. Including elements beyond the military component, such as civilian and police tasks, UN peacekeeping operations are also faced with a number of contemporary challenges such as: protection of civilians, limits on the use of force, member states capacities and their performances on the ground, and not exhaustively, the question of gender - in its various dimensions. In order to respond effectively to armed conflicts, the United Nations has, since the beginning of the 1990s, been undergoing a normative and institutional reform process that extends to the present day. As part of a broad debate on the balances and perspectives of peace operations, the Conjuntura Internacional Journal is organizing a special edition in the year in which these operations complete 70 years of existence to offer a reflection on the following issues:

- 1) The contributions of peace operations to conflict resolution;
- 2) Normative and institutional development from the 1990s and its future prospects;
- 3) Dilemmas and challenges for the protection of civilians in increasingly unstable contexts and with increasing risks for peacekeepers (such as terrorism, private security agents and other hostile elements on the ground);
- 4) The implications for the progressive authorization of the use of force in peace operations;
- 5) Discussions on the capacities and performances of member states;
- 6) Gender challenges: the low inclusion of women in formal peace processes and reconstruction, in the armed forces of the Member States of the United Nations, cases of sexual abuse and exploitation.
- 7) The difficulties of articulation between the United Nations, regional organizations and non-governmental organizations (NGOs) for the promotion of peace.
- 8) The Brazilian contribution, from a strategic, operational and tactical point of view for United Nations peace operations.

Other topics, as long as they are related to the proposed central axis, will be evaluated by the editorial team.

Applications are invited for a tenure track position at the rank of Assistant Professor, with a specialization in human rights. Candidates are expected to hold a doctoral degree in human rights or a related discipline, including but not limited to, history, political science, law or philosophy.
